MARINE INDUSTRY TRAINING REQUIREMENTS SURVEY: A NEW FORMAT BUT AN ONGOING COMMITMENT!

For the CSMOIM team, the arrival of fall means the beginning of operation annual marine industry training needs survey.

As you know, CSMOIM'S mandate involves being aware of skills and training requirements. The annual survey allows us to draw up a list of Québec maritime organizations' needs and to meet them.

This year, we will be sending maritime organizations a fully revised, revamped form (visually and technically). To make things easier for you, we will supply you with an interactive form that you can complete directly on-screen and return to us with a simple click.

The document also contains more extensive information on regulated marinesector training financial assistance eligibility criteria and on the latter's distribution process, among other things.

In mid-September, CSMOIM members will receive the 2014-2015 marine industry training needs survey form by email. Your participation is essential.


In addition to helping us tailor the training we offer to meet members' needs, survey results are important for regulated training financial assistance allocation.

SUCCESSFUL CONSULTATION OF MARINE OFFICERS

The continuing education working group (GTFC), whose creation we announced in the previous newsletter, successfully held a consultation of Québec's marine officers, as mandated by the CSMOIM Board of Directors.

The survey's goal was to get officers' opinions on issues facing their occupation, such as human resources shortages and career advancement. Thanks to the collaboration of many organizations, the working group was able to access a data base of more than 500 marine officers.

A total of 140 candidates completed the questionnaire distributed by Internet (20% response rate). B.I.P., the firm of consulting experts recruited by the working group, deems this result outstanding.

Respondents include Marine Engineers and Navigation Officers at all levels, thereby generating a representative portrait. Responses are being tabulated and the results will be incorporated into the working group's report to be submitted this fall.
