#### **COMING SOON:** A COMPREHENSIVE POR-**TRAIT OF LAND-BASED MARINE OCCUPATIONS IN QUÉBEC**

An important milestone was reached in the study on marine land-based occupations this past month, as discussions were held with Montréal-region workers. A dozen representatives of different occupations talked for two hours on themes such as the perceptions surrounding their work, what their friends and family think about the environment they work in and the training and hiring issues related to their occupations.

The content of these discussions will enrich the material already gathered through a survey administered to companies, adding a qualitative, human aspect to give the study more depth. At the same time, the inventories of organizations and occupations are nearing completion as is the analysis of the survey results. A preliminary final report should be tabled within the coming weeks.

# FIRST MARINE INDUSTRY HEALTH AND SAFETY WORKSHOP VERY PO-PULAR IN LONGUEUIL!

The first-ever workshop on marine industry health and safety regulations was held at Union des producteurs agricoles facility in Longueuil on November 10.

Organized jointly by Transport Canada and the Sectorial Committee, the activity attracted about 30 participants and shed light, among other things, on applying OHS regulations in the marine sector, differentiating between federal and provincial jurisdiction, understanding the role of various marine-sector organizations (CNESST, Transport Canada, etc.), being familiar with the accident prevention program and knowing about the process for reporting an occupational accident.

We would like to thank our speakers and partners, especially Line Laroche of Transport Canada, who prepared most of the program and recruited the experts for the different presentations.

### ANOTHER SUCCESSFUL GENERAL SHIPPING KNOWLEDGE TRAINING SESSION IN QUÉBEC CITY!

For the 2nd time in 2016, Québec City hosted our General Shipping Knowledge training session, last November 17.

As in April, the training ran at the Corporation des salles du Syndicat de la fonction publique et parapublique du Québec (SFPQ) and the session was attended by some 15 participants interested in learning more about the marine industry and its various stakeholders.

Given by Innovation maritime expert Nicolas Parent, the training session included two short presentations by marine-sector organizations. Anick Métivier from the Port of Québec spoke enthusiastically about his organization and its mission as well as discussing the major Beauport 2020 project, which is expected to entail significant development for the port and the Québec City area's marine industry. Also, Martin Fournier, of the St. Lawrence Shipoperators, talked about the nature, role and goals of the organizations he heads, highlighting the development of short sea shipping, a file SLS has been working on for a number of years.

This introduction to the marine sector was very popular with all involved!
