### **2016 JOB FAIR: A ROUSING SUCCESS!**

On April 1 and 2, the Sectorial Committee was on hand at the Centre de foires d'ExpoCité in Québec City to meet with 9500 job hunters from the Québec City area. Along with the Sectorial Committee, there were three other maritime organisations : Groupe Océan, Groupe Desgagnés and Verreault Navigation.

The two-day event was a rousing success for the Committee. We were able to tell job hunters about the new research filters for our website's Info-emplois maritimes (employment info) page and to promote various jobs available in companies that could not attend the job fair.



# THE COMMITTEE WAS PRESENT AT CMAC!

On April 19th two representatives of the Committee participated in a meeting of the Marine Personnel Standing Committee at the Canadian Marine Advisory Council in Ottawa.

This event allowed representatives from Transport Canada to address several maritime regulatory topics relevant to Marine Personnel such as:

- The time frame for the application of the new Marine Personnel Regulations;
- New leadership training requirements;
- The hours of work and rest:
- The time frame dilemma of medical certificates to be issued;
- Changes to courses of Marine Emergency Duties (MED);
- The new Small Vessel Operator (SVO) certificate.

Regarding the transition date of the amendment to the Marine Personnel Regulations (MPR), Transport Canada officials informed the participants that the official transition date of the amendment in Canada will not take place on January 1st 2017 since it's adoption will not completed. However, Transport Canada will take steps to ensure that the certificates issued in Canada are not penalized if they must exercise in jurisdictions where changes are already being implemented. Please consult our regulations column issue in May for a more complete account of all the points of the regulations of the Marine Personnel (RPM) and the changes taking effect as of January 1<sup>st</sup> 2017. The column will also address management systems safety and service at sea for the bridge personnel.

### FEEDBACK ON ISM-ISPS TRAINING

In collaboration with the Canadian International Bureau of Shipping (CIBS), the Human Resources Sectorial Committee of the Maritime Industry (CSMOIM) gave a training session on April 13 in Montréal on an introduction to the ISM Code and internal audits (ISM-ISPS).

The International Safety Management (ISM) Code (Code ISM) is an international standard for safe ship management and operation and for pollution prevention. The training session, led by Saïd Nassif, enabled participants to familiarize themselves with the ISM and ISPS codes and to better understand their purpose, the terms and conditions governing their application for commercial shipping, preparation for audits and the roles played by the various stakeholders involved.

Ships of 500 tons or more engaged in an international voyage are required to comply with the ISM Code. Transport Canada is currently in the process of changing the Safety Management System Regulations for domestic voyages. The draft Regulations will apply to Canadian-flagged vessels not governed by the Convention.

Watch for our soon to be published regulations column, which will summarize commercial shipping operations' safety management-related responsibilities under the ISM Code.
