Naval architecture technologists: first employers' meeting

At the invitation of the Sectorial Committee and the Institut maritime du Québec, employers wishing to hire naval architect technologists met in Québec City on February 20 for an update on the status of the program of studies and the profession in Québec.

Low college-level enrolment in the naval architecture technology program and employers' staffing difficulties are among the concerns expressed.

Participants agreed that program enrolment had to reach 20 to 25 students per year to better balance the job market. To do this, the profession needs to be given greater visibility so that young people take an interest in it.

The first step in this direction is to propose a communications plan that includes different promotion measures to be implemented in the medium and long terms.

MARINE PERSONNEL REGULATIONS WORKSHOP: A SUCCESSFUL GET-TOGETHER

We are pleased to announce that participation was at an all-time high at this year's Sectorial Committee regulations workshop.

The information session, which put the requirements governing navigating personnel into laymen's terms and provided an update on them, was attended by just over 80 representatives of member maritime organizations in Québec City.

February 18 was marked by many constructive exchanges between industry representatives and Transport Canada experts. Key issues were raised, notably work/rest rules for seafarers, small vessel operator training (SVOP) and security management systems.

To follow up on the meeting, the Sectorial Committee, in collaboration with Transport Canada, will present a report integrating participants' concerns at the Regional Marine Advisory Council meeting on March 11.

It is not too late to forward your comments for inclusion in the report.

Watch for the upcoming publication of a regulatory column featuring the themes addressed in the workshop!

In response to a question regarding the cost/benefit analysis questionnaire, we have been informed that it should be distributed with the draft Regulations when the latter are ready.

Both documents will be sent to all individuals, companies and institutions on the Canadian Marine Advisory Council (CMAC) mailing list. So, there are no special arrangements to make to obtain copies. However, anyone wishing to receive them can also request them later, either directly from the Sectorial Committee team or on the CMAC website.

SECONDARY SCHOOL STUDENTS ENJOY A MARITIME FOCUS!

On February 2, Sectorial Committee Training Coordinator Caroline Majeau visited some 50 secondary school and DEP access students at Le Tremplin at Sainte-Geneviève-de-Batiscan secondary school.

These young people are preparing to make career choices and Caroline took advantage of her visit to invite them to take part in a day-long exploration and discovery of maritime careers. The activity corresponded perfectly to the youngsters' academic guidance process and helped broaden their range of options regarding training programs available.

Concretely, the students attended a presentation followed by an enriched Math class featuring a marine cartography project directly linked to the concept of vectors.

The students also experimented with certain Navigation Officer duties by developing a voyage plan. Divided over several classes, the project reviews mathematics vectors and other concepts included in the Secondary V curriculum.

The Sectorial Committee was able to accompany some of the students and teachers from Le Tremplin school throughout this learning process applied to the maritime sector.
