# **ASSISTANCE FOLLOWING THE MARINE INDUSTRY TRAINING NEEDS SURVEY**

STATUS REPORT ON DISTRIBUTION OF FINANCIAL

The annual survey was forwarded to the Québec marine industry in mid-September and companies had until October 19, 2018 to return the duly completed document to the Sectorial Committee.

#### Emploi-Québec funding for marine-sector training

Of the companies that completed the survey form, 27 identified the need for financial assistance for regulated seafarer training. Respondents' funding requests totalled more than \$700 000. After compiling the results, the Sectorial Committee, in collaboration with the IMQ's Centre de formation aux mesures d'urgences (CFMU – Emergency measures training centre), made a proposal to the Ministère de l'Emploi for dividing the available funding of \$212 000, which the latter accepted. The period covered ends March 31, 2019.

The amounts allocated to each company must be earmarked by it before January 15, 2019. After that time, unused amounts will become available for all Québec marine-sector companies until no funding is left for training sessions offered before March 31. Marine-sector companies who answered the training needs survey will be given priority access to the remaining amounts.

#### Ministère des Transports funding for officer professional development

A new agreement recently reached with the Ministère des Transports du Québec renews, for five years (2018-2023), the financial assistance that can be used to pay 50% of the cost of training leading to Navigation Officer or Marine Engineering Officer certification. Holders of papers issued in other countries, who are in the process of converting them to obtain Canadian certification, are also eligible for this funding.

The annual amount available for this program is \$60 000, up \$10 000 from the previous agreement (2013-2018). To benefit from this funding, candidates must apply for it when registering with the CFMU. Candidates will be given a form used to determine their eligibility. Under the agreement with the MTQ, the Sectorial Committee grants the final authorization.

Given by Nicolas Parent, Senior Consultant with CPCS, the training also featured two short presentations on Québec City maritime organizations. QSL's Patrick Couture eloquently explained the field of stevedoring, what it is, its role and its involvement in the shipping chain, and the Port of Québec's Anick Métivier spoke enthusiastically about his organization, its mission and the major project Beauport 2020, expected to bring about considerable development for the port and the marine industry in the Québec City area.

On November 14, Claude Mailloux and Susan Falkner represented the Sectorial Committee at the CMAC Standing Committee on Personnel meeting that took place in Ottawa. The resulting important marine regulations-related information will be used to develop the program of the annual regulatory workshop to be held on February 20, 2019 in Québec City.

Transport Canada is also organizing a consultation tour on planned changes to the Marine Personnel Regulations, whose adoption is scheduled for 2019. The tour will be in Québec City on November 23.

## CAREER-RELATED EVENTS AND PROMOTION: A BUSY FALL

October and November were very busy for the Sectorial Committee team. Josée-Ève Poulin and Susan Falkner met with students making career choices and job hunters in Montréal on October 11-12 and in Québec City on October 18-20.



The Sectorial Committee also promoted marine-sector careers to professionals working in "carrefour jeunesse-emplois" youth employment centres on October 23 in Saint-Hyacinthe and took part in careers day at the Centre de formation en mécanique de véhicules lourds (heavy vehicle mechanics training centre), where the DEP in seamanship is given, on October 24.

The team concluded its promotional tour with the CargoM Career Day on November 19 in Montréal, where it met with transportation logistics students.

All of this followed on the heels of the Grande Fête maritime familiale (Maritime Family Fiesta) that ran in September at the Port of Québec and posted stellar results with 4500 visitors. On the whole, a busy series of activities that helped give interesting visibility to maritime careers at a time when they really need it.
