Small Vessel Operator Certificate

In the coming months, a revised version of the Marine Personnel Regulations is scheduled to be released and will change the regulatory requirements for navigating personnel certification.

As part of its mandate to monitor regulatory modifications, the Human Resources Sectorial Committee of the Maritime Industry (CSMOIM) wants to keep you abreast of changes to be made to the Regulations where the Small Vessel Operator Certificate is concerned. This column is based on the information available to us in April 2013. Its content is subject to change up until the time the revised version of the Regulations come into effect.

The goal of issuing this training certificate and the future certificate of competency is to ensure that candidates have a basic understanding of the hazards associated with the marine environment and their own vessel and the prevention of shipboard incidents. Transport Canada and the schools that provide this training want to ensure that candidates have the knowledge and skills required to safely operate a small vessel.

Currently in effect : Small Vessel Operator Proficiency (SVOP) training certificate

Training duration

Small Vessel Operator Proficiency training is offered by various schools recognized by Transport Canada. The course runs 26 hours at the end of which candidates who pass the required exam receive a training certificate issued by the teaching establishment in question.

New future certificate of competency: <u>Small Vessel</u> <u>Operator Certificate</u> (with coming into effect of revised Marine Personnel Regulations)

Training duration

Small Vessel Operator training will be offered by various schools recognized by Transport Canada. The new course is divided into four modules:

Basic module	Compulsory for all candidates	Duration : 34 hours
Fishing module	Compulsory for fishing vessels	Duration : 6 hours
Passenger module	Compulsory for small passenger vessels	Duration : 6 hours
Tugboat module	Compulsory for tugboats (2 months of sea service will be necessary)	Duration : 6 hours

Upon successful completion of this course, the school will issue a training certificate.

<u>The participant will then have to go to Transport Canada to obtain a</u> <u>Small Vessel Operator Certificate.</u>

Small Vessel Operator Certificate

Certificates to be given to the examiner :

- Small Vessel Operator training certificate issued by a school recognized by Transport Canada;
- Training certificate in MED with respect to small non-pleasure vessel basic safety;
- Marine Basic First Aid Certificate;
- Appropriate radio operator certificate (ROC or ROC with DSC mention or ROC-MC, depending on the navigation zone).

Transition period

The transition period will begin only once the revised version of the Marine Personnel Regulations has been released. At that time, a person who already holds a training certificate from a school recognized by Transport Canada for the Small Vessel Operator Proficiency (SVOP) training course will be credited the "Basic module" portion under the new TP 14692 "Small Vessel Operator training course".

Note that a person who holds a training certificate issued under the Marine Personnel Regulations (2007) may, after the revised version of the Regulations comes into effect, continue to operate a vessel of up to 5 gross tonnage (except tugs) engaged on a sheltered waters voyage or a near coastal voyage, class 2.

Small Vessel Operator Certificate - format and renewal

The new Small Vessel Operator certificate of competency should be presented in the form of a plastic card (credit card format).

For the time being, everything leads us to believe that this new Small Vessel Operator Certificate will not have to be renewed.
