Recently, Sectorial Committee member organizations received an email inviting them to complete the 2022-2023 training needs survey form. We would remind you that your participation is essential. In addition to enabling the Institut maritime du Québec's Centre de formation aux mesures d'urgence (CFMU) to adapt the training it offers to your actual needs, the survey results will be used to allocate Services Québec funding for regulatory training. Note that, again this year, only those who complete the survey will be eligible for this financial assistance.

MPR REGULATORY WORKSHOP

February is regulatory workshop month at the Sectorial Committee! The workshop will be given virtually due to the health-related measures in effect in Québec.

Six collaborators representing Transport Canada and the Institut maritime du Québec will be on hand for the workshop, whose goal is to summarize and explain the regulatory requirements governing marine personnel training and certification and to inform the maritime industry of current and future changes to the STCW Convention. FINANCIAL ASSISTANCE FOR OFFICERS’ CAREER PROGRESSION – 2019-2020 ANALYSIS

As you may be aware, funding earmarked for seafarer skills development is managed by the Sectorial Committee and the Centre de formation aux mesures d’urgence (CFMU). For 2018-2023, an agreement with the Ministère des Transports (MTQ) specifies that \$60 000 / year will be available under this program.
