For the campaign's third year, numerous steps have already been taken to present more of our industry's valuable actors and to encourage the public to also "get on board" where the maritime sector is concerned.

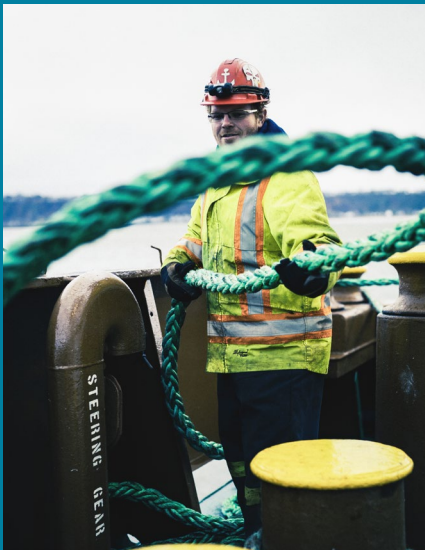

FUNDING FOR MARITIME TRAINING

Emploi-Québec

On April 1, 2021, the financial assistance program for maritime training for navigating personnel moved into a new fiscal year. Emploi-Québec has confirmed funding in the amount of \$200 000 for the current year and the amounts are now available for our industry. Maritime companies can benefit from regulated training for their employees working on ships. Companies must identify the candidates for whom financial assistance is being requested and these candidates must meet Emploi-Québec eligibility criteria. This funding was distributed in mid-March in collaboration with the Centre de formation aux mesures d'urgence de l'Institut maritime (CFMU). Maritime companies who completed the training needs survey have received letters confirming the amounts of funding granted.

Ministère des Transports du Québec

Since April 1, 2021, it has also been possible again for candidates taking training leading to officer certification to obtain financial assistance from the Ministère des Transports du Québec. This funding, which is set at \$60 000 and slated to cover 50% of training registration fees, had no longer been available since mid-March. Individuals have to register for the training sessions and apply to the CFMU for financial assistance at the time of registration.
